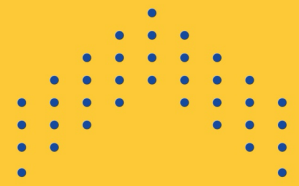

Program Overview

CPA Review Course Description (Core Parts)

Auditing & Attestation (AUD)

This course prepares students to pass the Auditing and Attestation section of the CPA Exam. Topics cover all subjects related to auditing, including audit reports and procedures, generally accepted auditing standards, attestation and other engagements, government auditing, and professional responsibilities.

Financial Accounting and Reporting (FAR)

This course prepares students to pass the Financial Accounting and Reporting section of the CPA Exam. Content covers generally accepted accounting principles in the United States (GAAP) that affect business enterprises, not-for-profit organizations and government entities, and the differences between IFRS and U.S. GAAP.

Regulation (REG)

This course prepares students to pass the Regulation section of the CPA Exam. Topics include federal taxation of individuals, property transactions and entities; ethics, professional and legal responsibilities; federal tax procedures and business law, as well as skills needed to apply that knowledge.

CPA Review Course Description (Discipline Parts)

Business Analytics and Reporting (BAR)

This course prepares students to pass the Business Analytics and Reporting section of the CPA Exam. Topics cover all subjects related to Risk management, financial management, Operations Management, Technical Accounting and Governmental Accounting.

Information System and Control (ISC)

This course prepares students to pass the Information System and Control section of the CPA Exam. Topics cover all subjects related to Regulations, standards and framework, Information system and data management, security and confidentiality and SOC engagements.

Tax Compliance and Planning (TCP)

This course prepares students to pass the Tax Compliance and Planning section of the CPA Exam. Topics cover all subjects related to tax compliance planning for individuals, corporations and entities, and property transactions.

To Pass the CPA Examination one must score 75% in each of the Papers.

Registration Procedures

Once you register with us you will be required to send Photocopies of all your Academic Documents (consisting of All Mark sheets & Certificates from Std. X till your current educational status) to an Evaluation Agency approved by the State Board. You will also have to select the State Board to where you wish to apply; we will guide you here. The Evaluation Agency shall evaluate your Credentials, equate your Educational Background with the American standards to see if you qualify to apply in that State for the CPA Examination, prepare an Evaluation Report on that basis, & get back to you in 4 to 6 weeks. It will simultaneously send a copy of the Eligibility (Evaluation) Report to the State Board. One Copy of the Eligibility Report is sent to you, the candidate. You will then have to apply to the State Board, along with the Examination & Application Fee & other relevant Documents, asking them to consider you as a Foreign Candidate. Within approximately two weeks of the approval of the application and payment of all fees, the state board or its designee will issue a Notice to Schedule (NTS) to the candidate. Once the NTS is received, candidates must verify the accuracy of all information. If any information is inaccurate the candidate must contact the state board before scheduling any exam with Prometric. If the NTS is accurate, students can then Pay the Balance

International Exam Fee at the NASBA Portal, wait for 24 Hours & then Schedule their exams with Prometric.

Eligibility

To qualify to write the CPA Examinations, one must be either an M.Com./CA/ICWA/MBA (Fin)/BE or other Graduate or Postgraduate with some Accounting Courses. No Practical Experience is required to write the CPA Examination. Qualifications required to sit for the CPA Exam in the USA vary between state boards of Accountancy. We assist candidates on an individual basis, to identify the State Board that satisfies his/her conditions. Upon obtaining the CPA Certificate, if one wishes to apply for a job then he/she can go straight ahead & apply. However, to Practice as a CPA in the USA, the candidate must obtain a License to Practice by working under the Direct Supervision of a Practicing CPA for 2-3 years in the USA in the Chosen Jurisdiction/State.
