### Core Sections

#### Financial Accounting & Reporting (FAR)

Focuses on U.S. GAAP for businesses, not-for-profit organizations, and government entities. Includes coverage of IFRS and how it differs from GAAP. This is the most comprehensive exam section, testing a wide range of accounting principles.

#### Regulation (REG)

#### Tax Compliance & Planning (TCP)

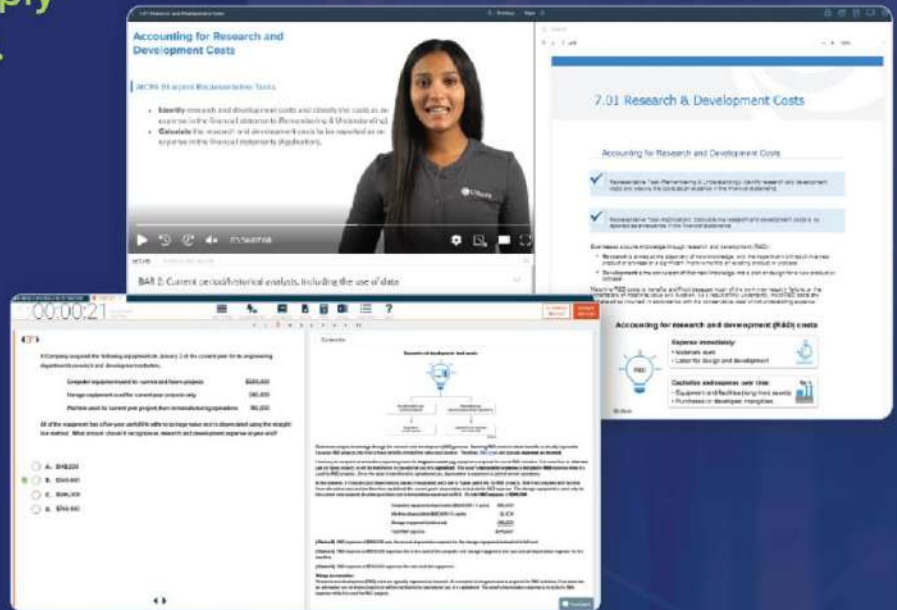

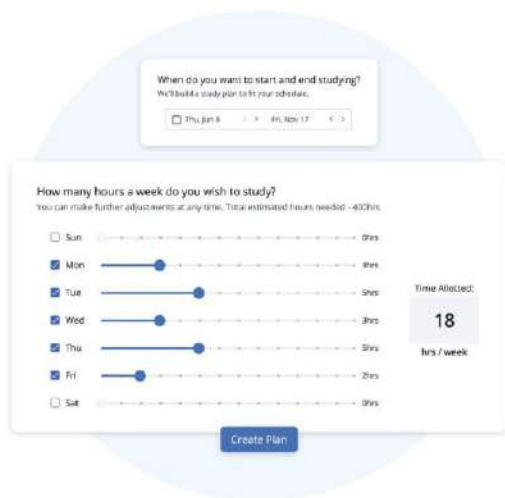

## Registration Process

1. **Document Submission:** Submit photocopies of all academic transcripts and certificates (from Std. X onwards).
2. **Credential Evaluation:** An approved evaluation agency compares your education with U.S. standards (takes 4–6 weeks).
3. **State Board Application:** Apply to your chosen State Board with application and exam fees.
4. **Notice to Schedule (NTS):** Once approved, you'll receive your exam authorization.
5. **Exam Scheduling:** Exams for the Core Section are offered throughout the Year, Monday-Friday, 8:30 a.m. to 5:00 p.m. & the Discipline Section Exams are currently offered in the 1<sup>st</sup> 2 Months of every Quarter at Prometric Test Centers. Pay international exam fees via NASBA, then schedule your exam at a Prometric Test Center (available in 8 Indian cities).

## Eligibility

You are eligible to attempt the CPA Exam if you hold:

- B.Com. / M.Com. / CA / ICWA / MBA (Finance) / BE, or another graduate/postgraduate degree with accounting coursework.
- No work experience is required to sit for the exam.

To practice as a CPA in the U.S., candidates must complete 2–3 years of supervised experience under a licensed CPA in their chosen state.

## Course Duration & Schedule

- **Program Length:** 6 months (26–30 weeks).
- **Class Frequency:** Sundays, 9:00 a.m. – 1:00 p.m. (4 hours per week).
- **Homework:** 3–4 hours daily study recommended.
- **Batch Start Dates:**
  - Late December / Early January
  - Late March / Early April
  - Late June / Early July
  - Late September / Early October
